Approval of Agenda:

Approval of Minutes:

Review of Financial Reporting:

Summary of Meeting:

New Business:

Moore and Pribyl explained situation CVPD was in with the City of Centerville and the housing – application regarding the narrative and explanation of the administrator. It was explained that the City of Centerville wanted CVPD to stay in the narrative for the application scoring but will be procuring for the administrator if awarded. Board discussed options and decided that if the CVPD keeps in the narrative a disclaimer will be added for future reference. Moore will check with state program manager for more details.

Wayne County HMGP update was given. Plan has been approved and CVPD working on getting grant closed out with Homeland Security.

Moore updated the board on an RFP from City of Chariton and her response.

Moore reviewed Title VI plan with board. This is a new requirement for all federal funding especially IDOT. Ryan made motion to approve plan for adoption. Hamilton seconded. All in favor.

IDOT update was given. Moore explained no more information could be provided regarding the Corridor Management Plan and Scenic Byway.
