# McCurdy Joins Chariton Valley Planning and Development Staff

Incorporated in May 2004, Chariton Valley Planning and Development will conduct business as a 501 (c)3 corporation for the purpose of enhancing economic prosperity and planned growth in order to improve quality of life in Appanoose, Lucas, Monroe, Wayne and contiguous counties in the State of Iowa. Primary activities will serve to stimulate and support: job creation; business investment; attraction and retention of a skilled workforce; quality of life, recreation, and cultural enhancements; provide for infrastructure installation and maintenance.

## Honey Creek Resort State Park

With the close of the legislative session came a collective sigh from the many southern Iowans who have been waging a campaign for the State of Iowa's first, full-scale destination state park. Following years of discussion and planning with the Iowa Department of Natural Resources, US Army Corps of Engineers, and Iowa's elected officials, Honey Creek Resort State Park on Rathbun Lake gets the nod and \$28 million in bonding authority for construction.

The Honey Creek Resort State Park on Rathbun Lake was a vision conceived by Rathbun Lake pioneers in the 1970s. Proponents, including the late Robert Beck and Joe Levis, touted the idea of a destination park on Rathbun Lake and even saw the State of Iowa purchase the real estate for such a notion in the mid-1970s. Until an all-out assault by regional supporters in the past five years, however, the concept of a hotel and convention center, guest cabins, golf course, and equestrian/recreation complex did not take root in the state-wide consciousness.

A meeting of historic proportion in southern Iowa was key to swaying the opinion of state policy-makers to give the Rathbun Lake "super park" a try. On May 18, 2000, nearly 800 supporters of the destination park on Rathbun Lake showed up at public hearing hosted by the Iowa Department of Natural Resources (IDNR) in Centerville.

The overwhelming turn-out of support at the Centerville public hearing was nothing less than amazing to IDNR staffers who had faced criticism at earlier hearings in the state where locales other than Rathbun Lake were suggested. An awestruck IDNR spokesperson, Arnie Sohn, issued a fitting response at the initial hearing when gazing upon the crowd, "Wow."

Many public hearings and meetings later brought milestone funding earmarks for the project. When efforts to secure a private developer to take on the entire project failed in late 2004, the strategy of bonding for the destination park and leasing out amenities to concessionaires was more fully explored and validated.



#### Governor Vilsack to Dedicate "Super Park" at Ceremony

At a special lakeside ceremony, Governor Thomas Vilsack will sign legislation to officially jumpstart construction of Honey Creek Resort State Park on Rathbun Lake. The dedication program is tentatively scheduled for Wednesday, June 15, 2005 at 10:30 AM at the building site.
